Manually attaching policy tags, for policies like retention or redaction onto existing content is simply inefficient in today's business environment. Every day 4.6 billion pieces of content flood businesses across the globe.¹ Managing, retrieving, delivering, storing, and archiving this content has proven increasingly complex. Businesses in every industry vertical need a content platform capable of responding to emerging challenges.

Many industries, particularly financial and healthcare, face additional regulatory challenges. Daily operations are further complicated by regulations like the HIP-PA Act or the Dodd-Frank Act, which can inflict heavy penalties as a cost of non-compliance. Most companies with global reach are aware of the European Union's (EU) General Data Protection Regulation (GDPR). This sweeping regulation increases citizens' (your customers') control of the information they share and harmonizes the EU's current data protection regulations. While GDPR makes it easier for non-European companies to comply with these customer data protection standards, the compliance expectation carries severe penalties for over exposure of customer information—as much as 4% of annual worldwide turnover or \$21.5 million.

In the late 1990's, Enterprise Content Management companies (ECMs) began addressing corporate standards and industry regulations by layering in policy based management administrative tools. While this policy layer approach has helped to address some of the issues discussed above, the resulting ECM became monolithic and cumbersome for enterprises of any substantial size.
